

Terms of Use

These Terms of Use (“the Terms”) apply to your access to the SophiaTX website www.sophiatx.com and its subpages, e.g. earlyadopter.sophiatx.com (jointly as “the Website”), which are operated by Equidato Technologies AG, with its registered seat at Innovation Tower, Industriestrasse 33, 5242 Lupfig, the Helvetic Confederation, identification No: CHE-174.378.377, registered at the Commercial register of canton Aargau, the Helvetic Confederation (“Equidato Technologies”, “we” or “us”).

By accessing the Website you acknowledge that you have read and understood the Terms, accept the Terms and agree to be bound by them. The Terms are intended for both, individuals as well as business customers.

The Terms govern your access to the Website. If you don't agree with (or cannot comply with) the Terms, you may not access the Website. If we make changes to the Terms, we will provide notice of those changes by updating the “Last Updated” date above and posting notice on the Website, which you need to accept.

1. SophiaTX

- 1.1. SophiaTX blockchain is the first open source platform integrating the blockchain technology with leading business applications, including major ERP, CRM and SCM solutions, allowing both users and integrators to use blockchain (“SophiaTX”). SophiaTX has been designed as a revolutionary blockchain platform and marketplace, integrating leading enterprise applications and solutions, covering major ERP, CRM, and SCM systems, into a collaborative environment across multiple industries.
- 1.2. It consists of (i) a blockchain specifically developed and enabled to power a B2B transaction engine; (ii) a development platform with integration APIs to SAP and other enterprise applications and, (iii) a marketplace for a global community of experts, consultants, and developers to buy and sell apps.
- 1.3. SophiaTX is open source, and designed to enable enterprise applications to be extended to more robust, collaborative and decentralized blockchain-enabled business models.
- 1.4. Integrating SAP and blockchain offers vast space for both users and the global economy. SophiaTX has capabilities for complex SAP programs in variety of assignments and disciplines - including global transformations and roll-outs, lean implementations, recovery and turnaround situations, mergers, restructurings, carve-outs, lean operations (i.e. management practices to reduce waste, improve cycle times, efficiency, etc.) and support.

2. COPYRIGHT AND INTELLECTUAL PROPERTY RIGHTS
